8.12.010 Definitions.

For the purposes of this chapter, the following words and phrases shall have the meaning respectively ascribed to them by this section.

Garbage: Any putrescible solid or semi-solid animal and/or vegetable waste material resulting from the handling, preparation, cooking, serving and consumption of food.

Industrial Solid Waste: Waste resulting from, or incidental to, any process of industry, manufacturing, mining or development of any agricultural or natural resources. This does not include waste materials, the discharge of which is subject to the rules and regulations of the Water Quality Division or mining materials subject to the Land Quality rules and regulations of the Wyoming State Dept. of Environmental Quality.

Municipal Solid Waste: Solid waste resulting from or incidental to residential, community, trade or business activities, including garbage, rubbish, ashes, street sweepings, dead animals, abandoned automobiles and all other solid waste other than industrial solid waste.

Refuse: Any putrescible or nonputrescible solid waste, except human excreta, but including garbage, rubbish, ashes, street sweepings, dead animals, offal and solid agricultural, commercial, industrial, hazardous, institutional, demolition and construction wastes.

8.12.020 Maintenance of premises generally.

A. It shall be the duty of the owner, agent, tenant, purchaser, contractor or lessee of any premises within the town, including places of business, dwelling houses, apartments, tenements, construction sites or other establishments, at all times, to maintain the premises in a clean and orderly condition, permitting no deposit or accumulation of materials other than those necessary or ordinarily attendant upon construction or upon the use for which such premises are legally intended. Any such accumulation is declared to constitute a nuisance and a nonconforming use of the premises.

B. All such persons, where cooking or eating is done, shall provide and keep at their expense, at all times, garbage cans which are suitable for the purpose of holding all garbage and refuse without running over.

8.12.030 Use of the Encampment Transfer Station.

It is unlawful for any person, persons, firm or corporation to use land or places within the jurisdictional limits of the Town other than the Encampment Transfer Station for the purposes of dumping ashes, refuse, garbage, municipal solid waste or industrial solid waste in a manner that is creating a

health hazard, public nuisance, or detriment to the environment.

8.12.040 Disposal Rules and Regulations.

The disposal of garbage, refuse, and trash shall be governed according to the signed agreement with the Upper Platte River Solid Waste Disposal District and their established rules and regulations.

8.12.050 Fee Required.

It is unlawful for any person, persons, firm or corporation to use the Encampment Transfer Station or the Saratoga Landfill without payment of a disposal fee, which fee shall be set by the Upper Platte River Solid Waste Disposal District and payable to the Town of Encampment.

8.12.060 Burning Prohibited.

Burning of garbage, refuse, municipal solid waste, or industrial solid waste within the Town is prohibited.

8.12.070 Violation – Penalty.

Any person, persons, firm or corporation who is responsible for failure to comply with the provisions of this chapter is guilty of a misdemeanor and upon conviction shall be fined not more than seven hundred fifty dollars (\$750.00) for each violation, together with court costs. Each day shall constitute a separate violation.
